



Membership Classifications and Fees

There are two basic classifications of memberships:

- 1. Association-only Membership**
- 2. Association/Recreation Center Membership**

Association Membership is included with the fee for Recreation Center Membership.

ASSOCIATION-ONLY MEMBERSHIP

\$90 annually

Association-only Membership enables you to help enforce and support Big Trees Village CC&Rs and ensure Design Review of new development.

It is not required that you join the Recreation Center to be an Association-only member.

Benefits

- **3 free days at the Recreation Center** (family members only; not including July 3-5)
- Full-time, year-around Association management on site

- CC&Rs enforcement
- Information concerning CC&Rs, Fire Prevention, County Services, area activities, and Recreation Center activities
- Members vote for Association Board members and can attend all meetings
- Members may attend certain Recreation Center functions (e.g., potlucks, barbecues, bingo)

ASSOCIATION/RECREATION CENTER MEMBERSHIP (TWO OPTIONS)

Family Use Membership

\$405 annually

This classification allows for Recreation Center use by immediate family members defined as husband, wife, children and their spouses, grandparents, grandchildren, and siblings. All other guests must be accompanied by the member and are limited to ten (10) at a time.

Benefits

- Recreation Center Use in 2010:
 - Memorial Day Weekend
 - Weekends of June 5 and June 12
 - June 19 - September 6 Daily
 (Refer to Summer Activities Calendar for specific use times)
- Free Swim Lessons for Children (Monday - Friday)
- Lap Swim (Monday - Saturday)
- Adult Water Exercise (Monday - Friday)
- Children's Playground
- Sports Facilities including tennis, ping pong, baseball, basketball, volleyball, shuffleboard
- Special Activities for kids and teens
- Snack Shack

Family, Unaccompanied Guests & Rental

Property Use Membership

\$685 annually

This classification allows for Recreation Center use by non-family and friends staying at your Big Trees Village home when you are not with them, as well as people renting your home, either through an agency or by yourself. There will be no extra charge unless there are more than ten (10) in the group. A \$5 per person charge for each person over ten will be collected (in cash) at the Recreation Center gate. For groups of more than ten people, management is to be notified a week in advance. The same benefits and rules listed in the Recreation Center Family Use Membership apply.

New Association/Recreation Center

Membership Initiation \$200 one-time fee

This one-time fee gives you the flexibility to not belong to the Recreation Center in a particular year, then rejoin in later years, without having to pay an initiation fee again, as long as you maintain an Association-only Membership each year.
